WHEREAS there is no direction as to who would perform the research on everything prior to the RM being able to accept an offer from any entity, and the time incurred to do the said research will increase the workload of whoever would be doing it, and the extra costs would fall on the Ratepayers.

WHEREAS without grants, the financial burden to Ratepayers would be substantial.

BE IT RESOLVED that we rescind Resolution 354.OCT.25. **CARRIED.**
