

RURAL MUNICIPALITY OF SASMAN NO. 336
MINIMUM TAX
BYLAW NO. 2025-04

A bylaw to establish Minimum Tax for the RM of Sasman No. 336 and Hamlets.

The Council of The Rural Municipality of Sasman No. 336 in the Province of Saskatchewan enacts as follows:

1. This bylaw shall be known as the “Minimum Tax” bylaw.
2. The following Minimum Tax shall be applied to the Uniform Mill Rate levied against all taxable property within the RM of Sasman No. 336 and Hamlets for municipal purposes:
